ERCB Updates:

Launching new website with new search functions. Question 1: How long has Darren been on the board? Greater than 10 years. Question 2: What is the comment of the board over these past 3 oil spills? The board is working hard at investigating the root cause of these spills. The oil company is responsible for the cost of the clean up. Question 3: Is it common practice to leave oil in pipelines that have been left dormant? No. Question 4: How much pipeline is being replaced on a yearly basis? Would have to inquire. Question 5: When a company is mandated to repair or remove a line is that public information? Yes to the landowner and also published on the website.

Industry Updates:

Advantage: No updates to report. Landowner concern over gate being left open. Monte to look into the matter.

BayTex: Routine operations.

PennWest: As per map info provided- Expanding 3 existing leases. Proposal for a pipeline. Four wells will be changed to injector wells. One new location for a compressor. One new well. Projects planned for the first quarter of 2013.

Scollard: Trevor Krause is working with us and here to give the update.. No work in the immediate area. One rig job north. Pursuing a surface lease we hold north of the synergy group.
